## TERMS & CONDITIONS Consumer Travel Fair The Netherlands 2021

### **1. ITN Marketing Agrees:**

To carry out the project described, on the condition that the required numbers of participants apply. To provide to participant the following workshop services:  
USA & Canada Reisbeurs a 2-day consumer Travel Fair for consumers.

### **2. The Participant Agrees:**

To submit a completed registration form for participation, duly signed to ITN Marketing before the applicable deadlines, latest deadline is September 15<sup>th</sup>, 2021. After this date the application can only be on demand and the sole decision of ITN Marketing, a 15% surcharge will be applicable.

Any outstanding payment after September 15<sup>th</sup> will have a 15% surcharge on top of the highest applicable fee.

**Deadline total payment will be mentioned on the invoice and binding for the applicable entrance fees of the event at the time your registration was received.**

Upon registration the participant will receive an invoice for the total amount. Full payment deadline will secure participation. Payment after this deadline date will result in a higher fee as mentioned on the registration form per different set deadlines and these term & conditions.

To carry its own property and liability insurance.

To take responsibility for all costs for shipping, duties, handling of all own material and exhibits and the removal of send material from the workshop site after the event. If in any case duties do apply these will be invoiced separately. ITN has the right to have any material left by participant removed after the close of the show at participant's expense.

To authorize ITN to mail and/or email participant materials related to this event and other events of potential interest.

**Order Payments: Payment for all or optional services and equipment must be made by wire transfer including all banking costs. Payment by cheque will have a surcharge of €150 for banking costs to be added on top of the total invoice by your own administration directly.**

### **3. Other Conditions:**

ITN has the sole authority to assign, reassign and allocate space. Participant registration will be processed in the order they enter and when payment is received. ITN reserves the right to accept or refuse applications for any reason. Confirmation of participation, as well as space allocation is made solely by ITN. USA & Canada Reisbeurs participation is open to European, Canadian and American organizations, their overseas subsidiaries, agents, representatives and licensees, as well as to companies and organizations promoting travel and tourism to or in Canada or the USA.

Participant may not sublease contracted booth space without written consent from ITN. Although ITN will make every effort to facilitate a successful Reisbeurs, it does not guarantee the success of any participant at the USA & Canada Reisbeurs. The only contractual obligation ITN assumes are those expressly made herein or mutually agreed to in writing. Participant releases ITN and the show organizers from liability for any illness, injury, loss of life, damage to persons or property by reason of participation in the USA & Canada Reisbeurs, or by reasons of acts by participant, its agents, employees, contracted labour or clients. Also in the event of unforeseen circumstances like pandemic and/or act of God. If, for any reason.

A participant who cancels it's participation and a written notice is received by ITN before September 1<sup>st</sup>, 2021, a cancellation fee of 75% will be incurred. After that date no refunds will be made, and participant is bound to pay 100% of all fees paid and due. If due to the pandemic last minute cancellation of the event has to be made by ITN due to change of the regulations of location and or government restrictions, there might be a small refund possible but only after deduction of all costs of the organisation and on the sole decision of ITN. Any reduction in booth space size after a registration has been submitted will be treated as a cancellation. The payment submitted with a registration is only than fully refundable in the event the participant is not approved by ITN, or no more booth space is available. These Terms and Conditions overrule all other conditions, rules and regulations laid down by ITN and/or the show organizers.
